

2. SCOPE OF WORK

1. Including all the plants, trees, lawn, Pathways, Ticket room, Guard room, Lights, Play equipment's ,Fountain ,Boating facilities, three Boating Facilities, Cafeteria, Garden light, Boring with Motor, Toilet (01Nos) Open Space etc. as **present Condition of Park** to the specified premises for Three (03)Years from award date of contract .The essence of contract and no let down will be permitted in any respect.
2. Contractor will be permitted Advertisement in park in specified area through Hording, Board on grill and Glow sign Boards.
3. Contractor will be permitted to Collect Entry fee as decided by Chas Municipal Corporation



The intending bidder shall have to submit self-attested all documents as per **annexure - I**

1. The Tenderer will have to submit Character Certificate issue by D. C, Concern District
2. Submission of latest three month GST returns and PAN No is mandatory.
3. The Tenderer will have to submit 03 financial years, Turn over certificate issue by the Charter Accountant.
4. The bidders cannot participate in Tender/Auction, who has been Black listed/Debarred in anywhere ULBs in India.
5. Priority for Operation & Maintenance will be primarily given to the Contractor in the Auction, who has successfully completed Operation and maintenance of any park without any litigation.
6. Chas Municipal Corporation reserves the right to cancel tender in full/part, extend tender sale/submission date etc. without assigning any reasons thereof.
7. Amount quoted on Auction bid should be excluding of all taxes.
8. The Successful bidder shall arrange decentralized composting for Plantation.
